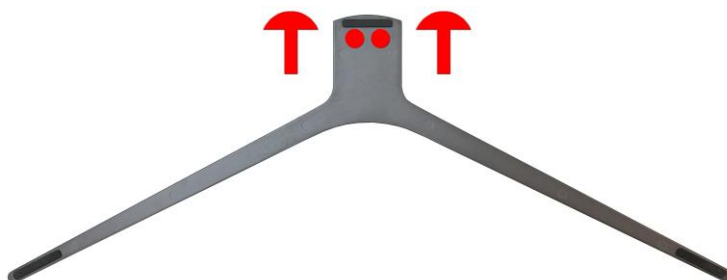
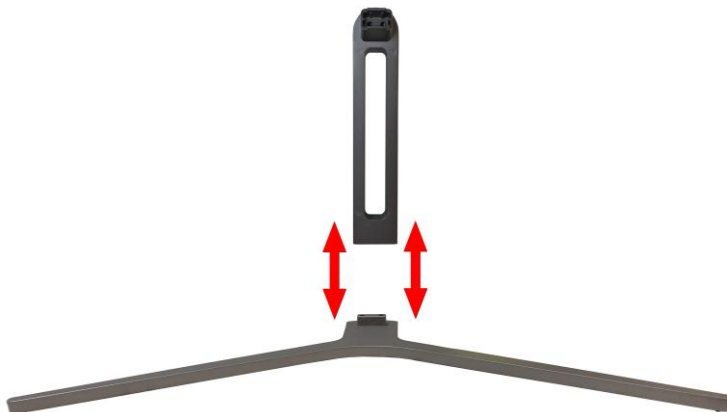

Installation

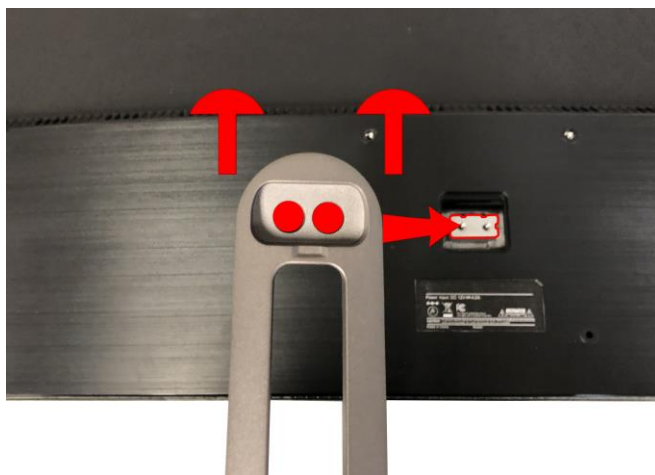
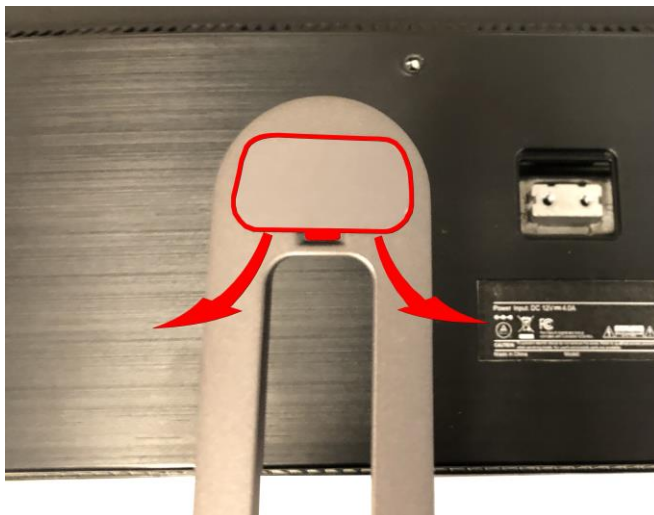
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

1. Connect the neck to the base and secure the installation by screwing in the 2 screws from the bottom of the base.



2. With the monitor in the packing foam, place the monitor face down on a table. Open the rubber piece on the back of the neck and connect it to the back of the monitor. Screw in the 2 screws to secure the installation.



3. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment






The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $5\pm 2^\circ$ forward and $15\pm 2^\circ$ backward with a combined angle of $18\pm 4^\circ$.

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

Rear View with Buttons



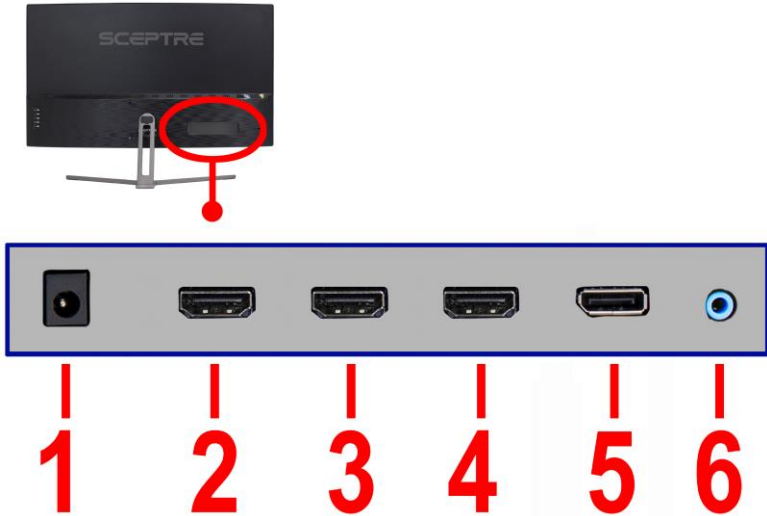
1.  – This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2.  – With no OSD, this button cycles between PRESET modes. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
3.  – With no OSD, this button activates a permanent crosshair for first person shooting games. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
4.  – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5.  – This button turns the display on or off.

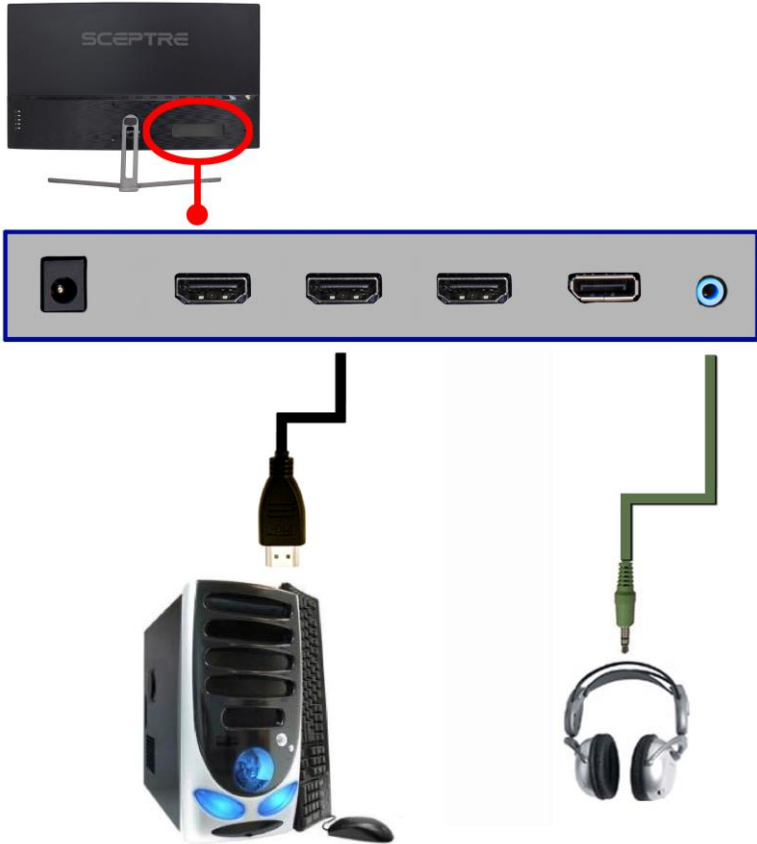
1. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 3** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. This connection supports up to 120Hz refresh rate.
3. **HDMI 2** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. This connection supports up to 120Hz refresh rate.
4. **HDMI 1** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. This connection supports up to 120Hz refresh rate.
5. **DISPLAY PORT** – Display port is a digital video connection for connection to computers with display port video output. This connection supports up to 185Hz refresh rate.
6. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

1. **TEMPERATURE** – This option let users select different color temperatures of the monitor.
 - a. **NORMAL** – This color temperature is for users who prefer a neutral white balance.

1. **OVERDRIVE** – This option increases the pixel response time of the LCD screen.

Troubleshooting

Problem	Possible solutions
THERE IS NO LED DISPLAY or SCREEN SAYS NO SIGNAL	<p>Make sure you switched to the correct source. Check both sources to see video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.</p>
MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60 Hz via your video card's display settings menu. After the setting of 60 Hz has been change you can then use the LED on the computer.</p> <ol style="list-style-type: none"> 1. To change the setting go to display settings by right clicking on your desktop with nothing selected. Choose the PROPERTIES option. 2. How do I clean the LED Monitor?
