



Installation


Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $5\pm 2^{\circ}$ forward and $15\pm 2^{\circ}$ backward with a combined angle of $18\pm 4^{\circ}$.

Please Note:

• When adjust the angle of the monitor, be sure not to touch or press the LCD screen.




