This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. - To avoid the risk of electric shock or component damage, switch off the power before connecting other components to the display.

Installation

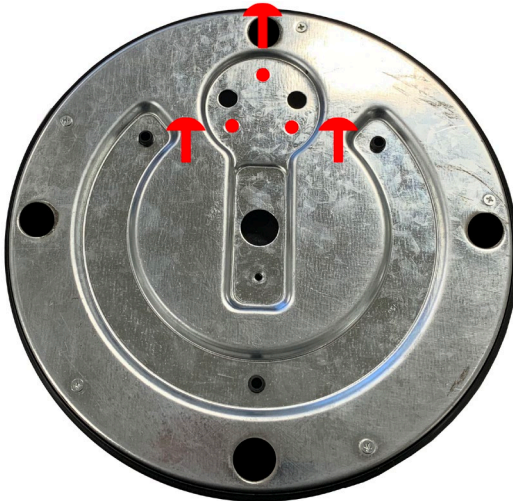
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

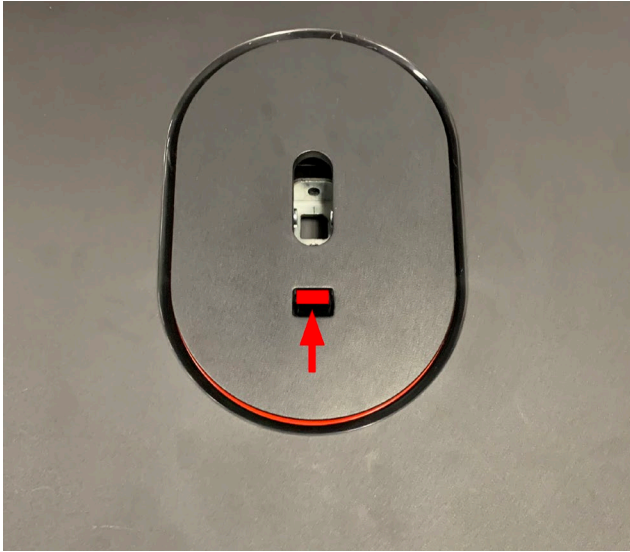
1. Take the monitor out of the box. Lay the monitor screen facing down on a table with the monitor still resting on the packing foam. Obtain the display neck and attach it to the display neck.



2. While the neck is attached to the base, insert and tighten 3 screws to the bottom of the base.



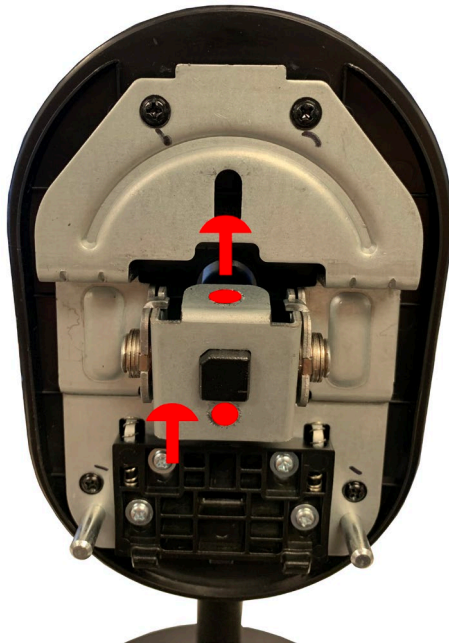
3. Locate the switch on the back of the display. Push up and lift the back plate off the display.



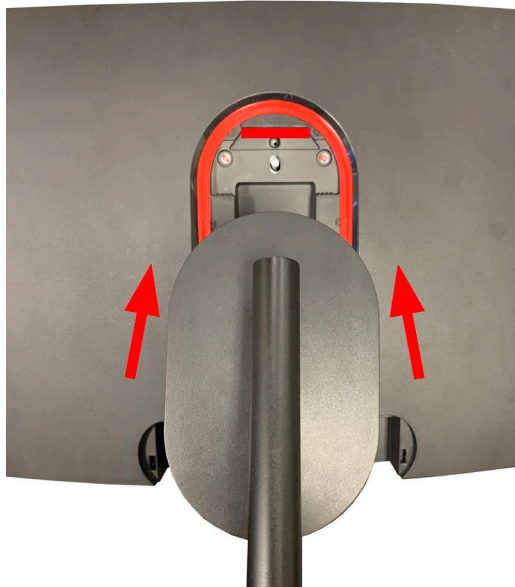
4. Insert the back plate to the neck + base (stand) assembly.



5. Secure the installation by inserting and tightening 2 screws.



6. Insert the stand + back plate into the back of the display.



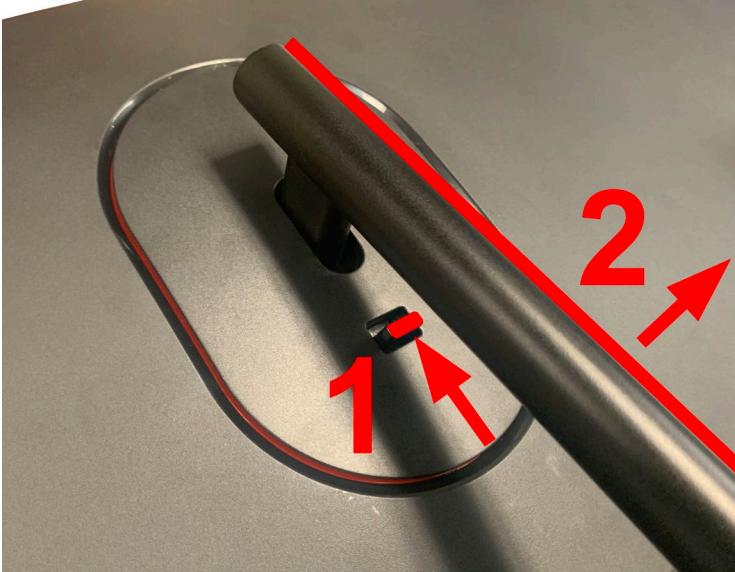
7. Use your thumb and press down on the bottom of the back plate until the plate locks with the back of the monitor.



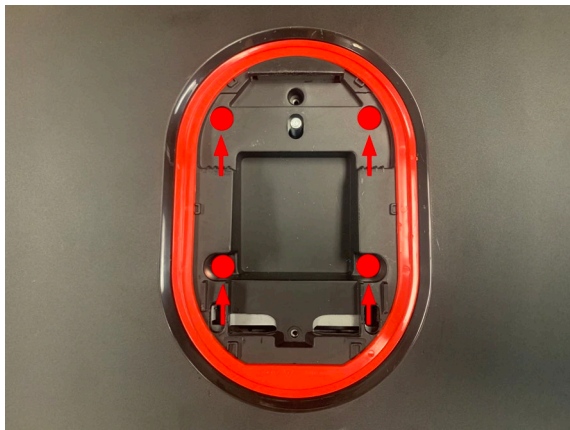
8. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Removing the Stand for Wall Mounting

1. To uninstall the stand assembly, lay the monitor facing downwards on a table. Locate the switch. Push the switch upwards and lift the neck upwards. You should be able to take the entire stand off the back of the monitor.



2. Once the stand is removed, you will see the indentation where you can install 4 mounting spacers. Insert and tighten the spacers and you can mount the monitor. **The mounting pattern is 75mm x 75mm using M4 x 7mm screws.**



S Light Module Installation

The S Light Module is a light module that displays a red S sign on the base if turned on.

1. To install the optional S Light Module, lay the monitor flat on a table with the screen facing downwards and look for the micro USB socket at the bottom of the display.



2. Insert the optional S Light Module into the micro USB socket.



3. Access the display's OSD and enable the S Light option to turn on the S Light.

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $2\pm 1^\circ$ forward and $10\pm 1^\circ$ backward.

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

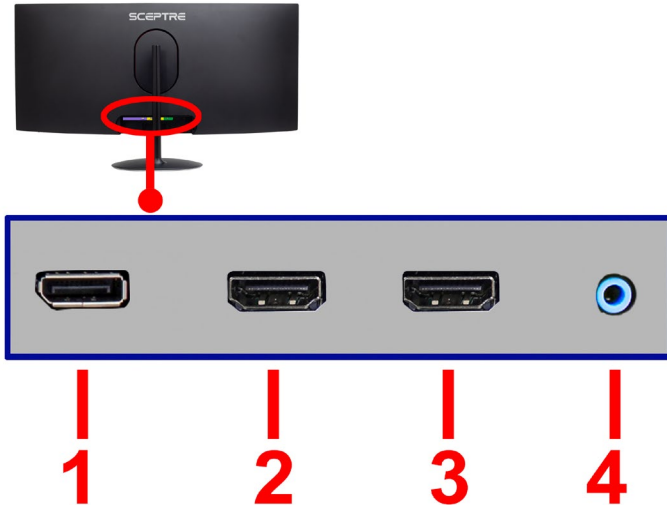
Front View with Buttons



Buttons from right to left

1. **M** – This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – With no OSD, this button activates a permanent crosshair for first person shooting games. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
3. **▲** – With no OSD, this button cycles between PRESET modes. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

Rear View with Connections



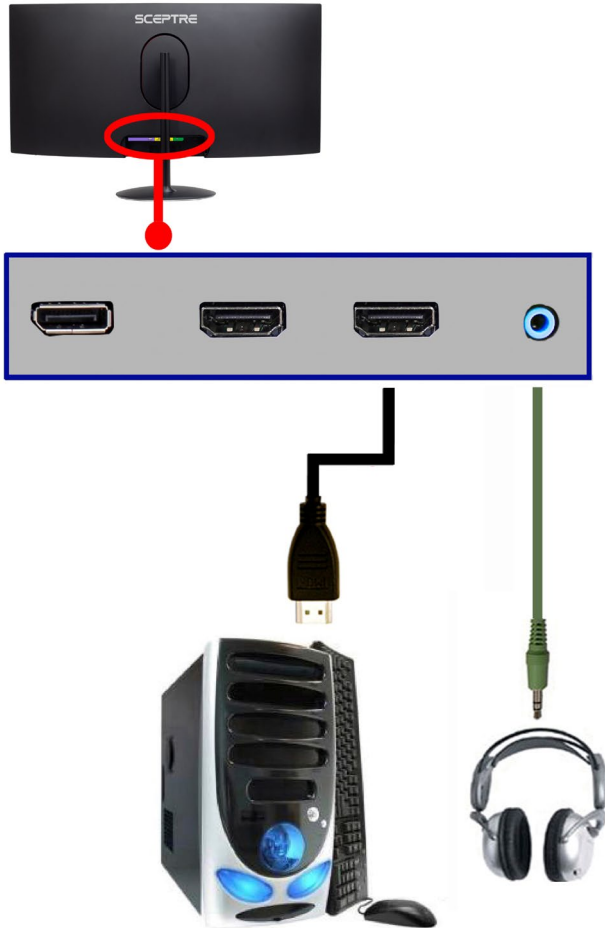
1. **DP** – DisplayPort (DP) is a digital video connection for connection to computers with display port video output.
2. **HDMI 2** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering.
3. **HDMI 1** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering.
4. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Please Note:

- Adaptive Sync is always turned on for HDMI ports.
- In order to remove the DP cable from the monitor you need to depress the buckle on the cable while unplugging.

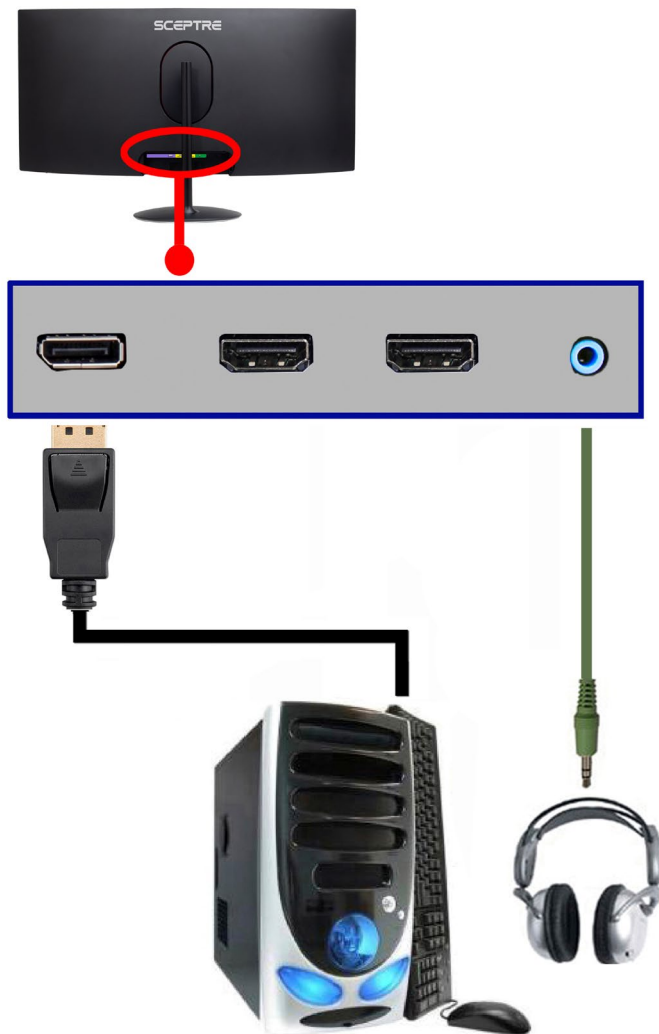

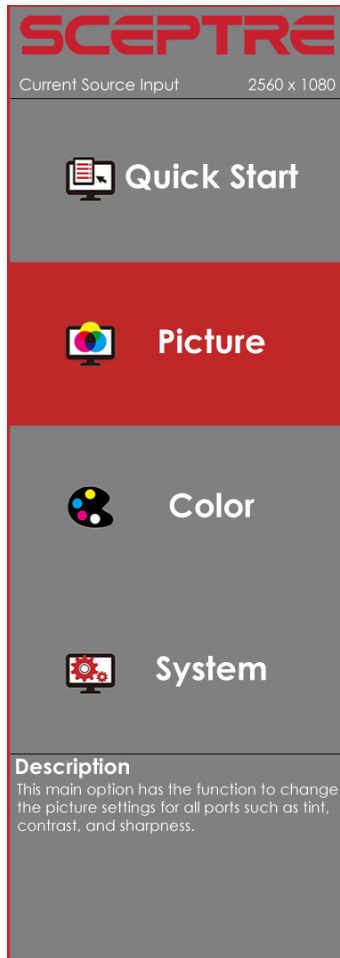

On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrastetc.



When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the **▲** or **▼** buttons. Use the **M** button again to enter each of the function or when you're in the function already, use the **M** button to select the option you want to adjust. Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit press the **E** button.



1. **TEMPERATURE** – This option let users select different color temperatures of the monitor.
 - a. **NORMAL** – This color temperature is for users who prefer a neutral white balance.
 - b. **COOL** – This color temperature is for users who prefer a cool white balance.
 - c. **USER** – This color temperature is for users who would like to adjust the RGB (red, green, blue) values manually.
 - i. **ADVANCED** – This setting adjusts finer values besides RGB going into cyan, magenta, and yellow.
 - d. **WARM** – This color temperature is for users who prefer a warm white balance.
2. **GAMMA** – This option adjusts the gamma curve value of the monitor.
3. **TINT** – This option adjusts the tint of the entire monitor.
4. **SATURATION** – This option adjusts the color saturation of the entire monitor.

1. **OVERDRIVE** – This option increases the pixel response time of the LCD screen.
2. **ADAPTIVE SYNC** – This option turns on or off the Adaptive Sync function, which reduces screen tearing with compatible graphics cards.
3. **SLEEP MODE** – With the monitor given no video signal, enabling this option will make the monitor automatically shut off after 30 minutes, 60 minutes, or 2 hours.
4. **S LIGHT** – This option turns on or off a red light S sign that projects onto the desk.
5. **LANGUAGE** – This option allows users to change the menu language of the monitor.
6. **OSD H POSITION** – This option adjusts the placement of the OSD menu horizontally.

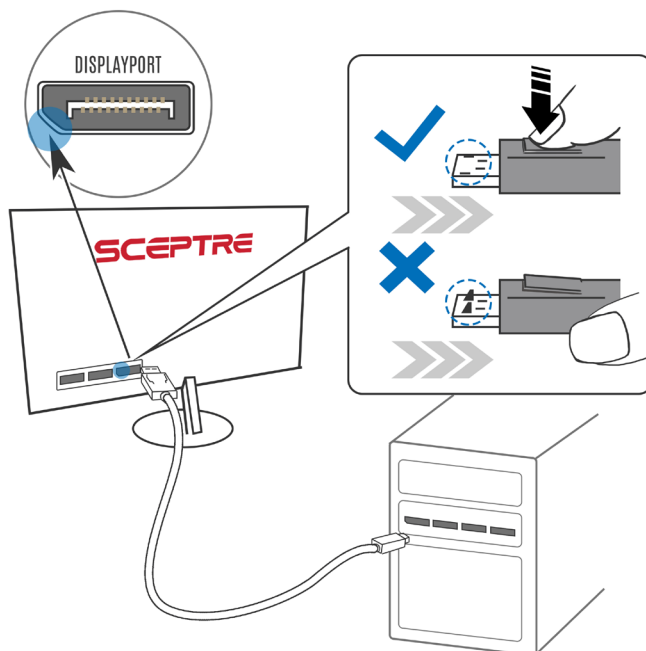
Problem	Possible solutions
THERE IS NO LED DISPLAY or SCREEN SAYS NO SIGNAL	Make sure you switched to the correct source. Check both sources to see video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.
MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60 Hz via your video card's display settings menu. After the setting of 60 Hz has been changed, you can then use the C34 LED Monitor on the computer.</p> <ol style="list-style-type: none">1. To change the setting go to display settings by right clicking on your desktop with nothing selected. Choose the PROPERTIES option.2. Click on the SETTINGS tab, verify the resolution is NOT higher than 2560 x 1080, and click on the ADVANCED button.3. Click on the MONITOR tab and change the refresh rate to 60 Hz.4. Click on OK 2-3 times to finalize your change. <p>If you do NOT have a CRT monitor or it's already broken, please make sure both the C34 LED monitor and your computer is turned off.</p> <ol style="list-style-type: none">1. Turn on the LED monitor and the computer.2. While the computer is turned on, press the "F8" key on your keyboard continuously until a selection menu appears and select the "Safe Mode" option.3. Problem	Possible solutions
<p>I CANNOT GET THE RESOLUTION 2560 x1080</p>	<p>Sometimes your video card will not read the monitor correctly and will not allow you to achieve the resolution you want. Rebooting your computer will solve the situation.</p> <p>You can also make sure your video card's video drivers are up to date. You can find what video card you have by clicking on START then RUN. Type in "DXDIAG". When the diagnostic window pops up, click on the DISPLAY tab. The program will tell you what video chipset you have. <p>THE COLORS ARE NOT CORRECT</p>	<p>Sometimes the colors are not correct because your DVI or DP or HDMI cable is loose or corrupt. Please try reconnecting your cable or swap out your current cable to see if the problem persists.</p>

<p>THE WORDS ARE TOO SMALL AT 2560 x1080</p>	<p>At the native resolution of 2560 x 1080, some people might feel that the words are too small to read. You can change the size of the words in Windows Operating System via its display properties.</p> <p>For Windows XP</p> <ol style="list-style-type: none"> 1. Right click on the background with nothing selected. Left click on the PROPERTIES option. 2. Click on the SETTINGS tab. 3. Under SETTINGS, click on the ADVANCED button. 4. Under GENERAL tab, change the size of the words by selecting the option NORMAL SIZE and change it to LARGE SIZE. 5. Click on OK on all windows to exit. 6. Once you have finished rebooting, the computer is ready for use. <p>For Windows VISTA or Windows 8 or Windows 10</p> <ol style="list-style-type: none"> 1. Right click on the Wallpaper. How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the monitor?

IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.

Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel in order to prevent water from penetrating into the electronics.

Cleaning the Screen

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. The LCD screen glass is extremely fragile. Do not scrape it with any material. Do not press or tap the screen to avoid cracking. When the screen is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.
