# IMPORTANT INFORMATION

This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. - To avoid the risk of electric shock or component damage, switch off the power before connecting other components to the display.

# Installation

---

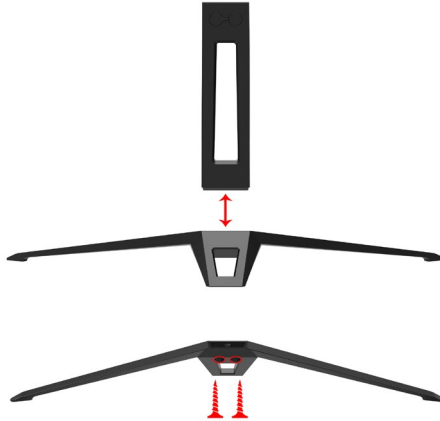
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.



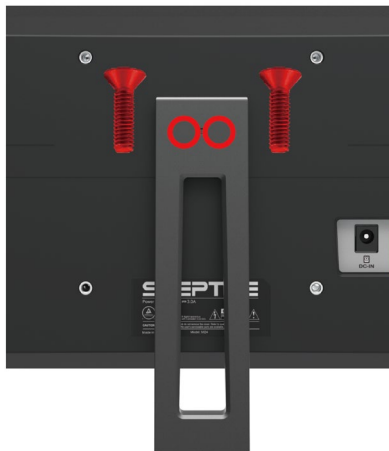
# Installing the Monitor Stand Assembly

---

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Install the neck to the base and insert the 2 base screws from the bottom. Tighten the screws to secure the base.



2. Install the assembled stand to the back of the monitor and screw in the 2 neck screws to secure the stand to the monitor.

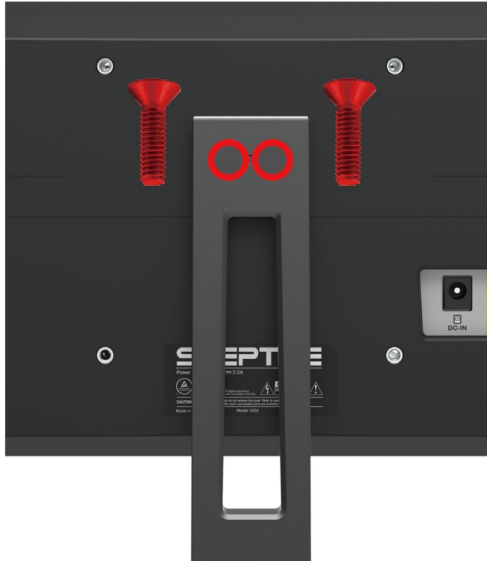


3. Insert the rubber cover to the back of the neck.
4. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.

# Removing the Stand for Wall Mounting

---

1. To uninstall the stand assembly, lay the monitor facing downwards on a table. Remove the rubber cover and unscrew the two screws to remove the stand.



2. The mounting pattern is 100mm x 100mm using M4 x 10mm screws.

# Identifying Front and Rear Panel

---

## Front View



**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

## Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined  $-5^{\circ} \sim 15^{\circ}$ .

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

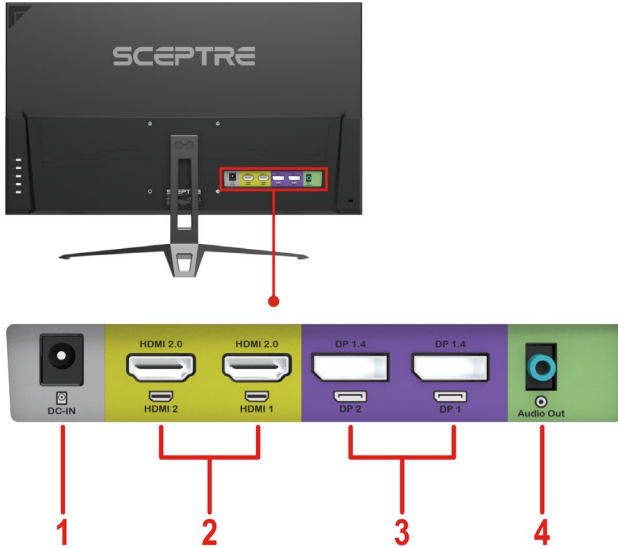
## Rear View with Buttons



### Buttons from right to left

1. **M** – This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▲** – With no OSD, this button increases the volume of the monitor's speakers. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
3. **▼** – With no OSD, this button decreases the volume of the monitor's speakers. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

## Rear View with Connections



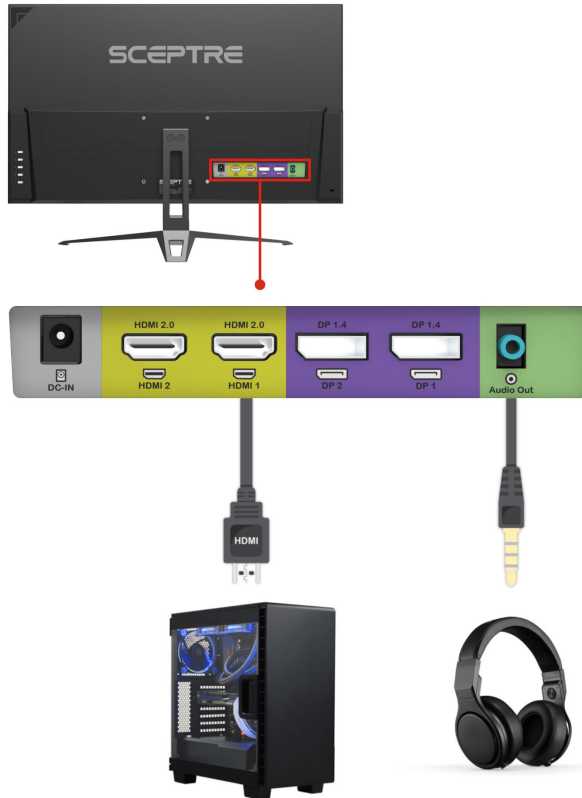
1. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 1-2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. HDMI 1 and 2 are both HDMI v2.0.
3. **DISPLAYPORT1-2** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. Both DisplayPort is DP v1.4.
4. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Please Note:

- HDMI1-2 at native resolution 1920 x 1080 will support 180Hz.
  - DP1-2 at native resolution 1920 x 1080 will support 180Hz.
- To remove the DP cable from the monitor, you need to depress the buckle on the cable while unplugging.

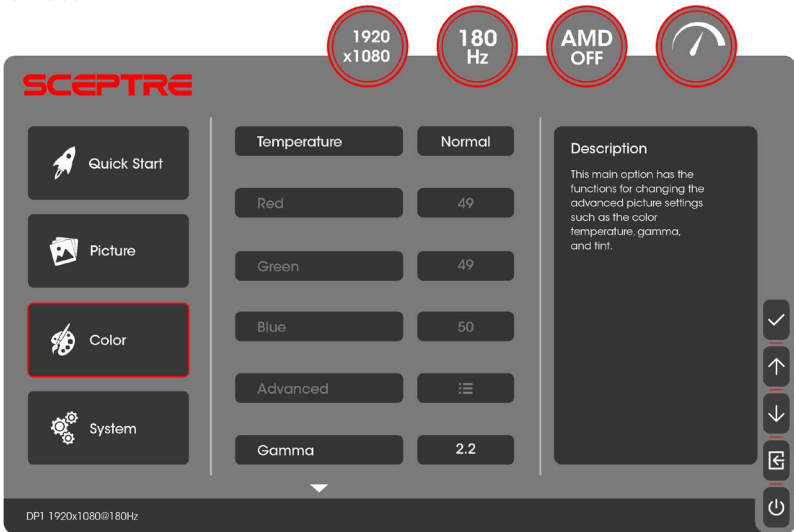

## How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



# How do I clean the monitor?

---

## IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use a volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

## Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry microfiber cloth or 100% cotton cloth afterward.

Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel to prevent water from penetrating the electronics.

## Cleaning the Screen

1. Use a 100% cotton cloth or microfiber cloth for cleaning.
2. The LCD screen glass is extremely fragile. Do not scrape it with any material. Do not press or tap the screen to avoid cracking. When the screen is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry microfiber cloth or 100% cotton cloth afterward.
